
COMES NOW the Defendant, JOSEPH TURNER, by and through his undersigned

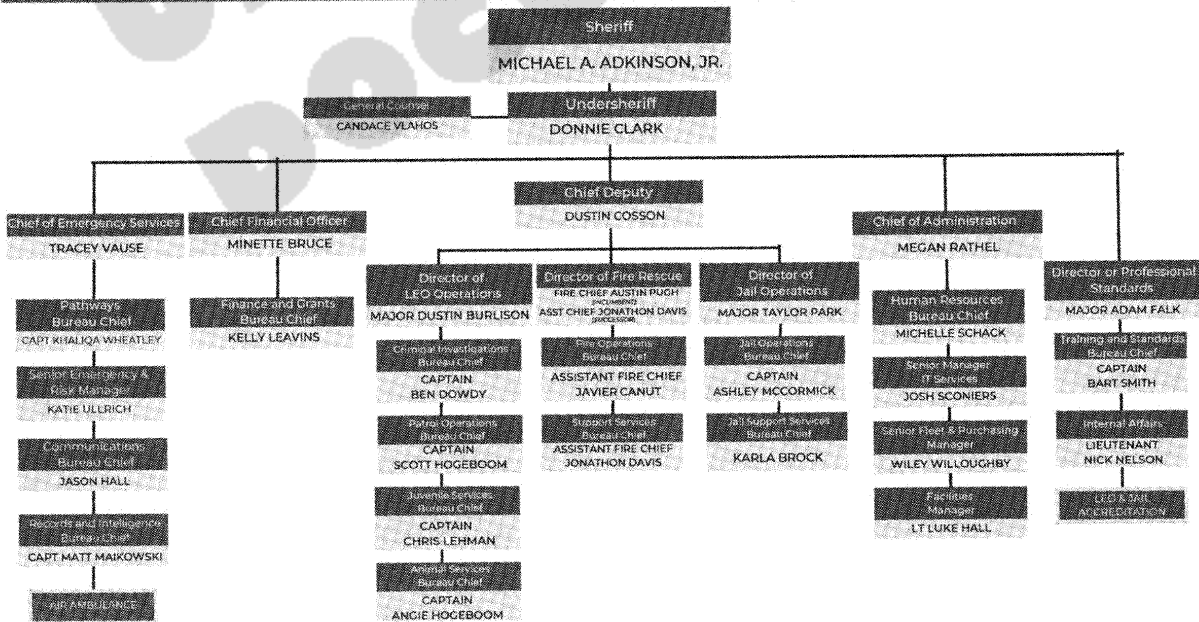

February 24, 2026

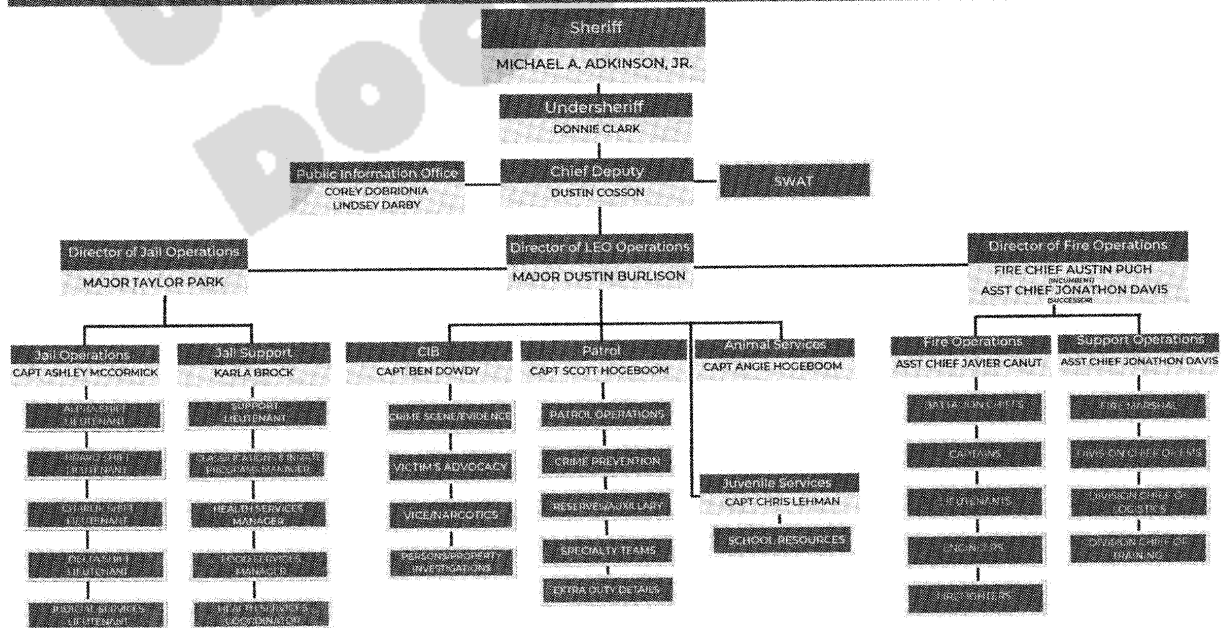

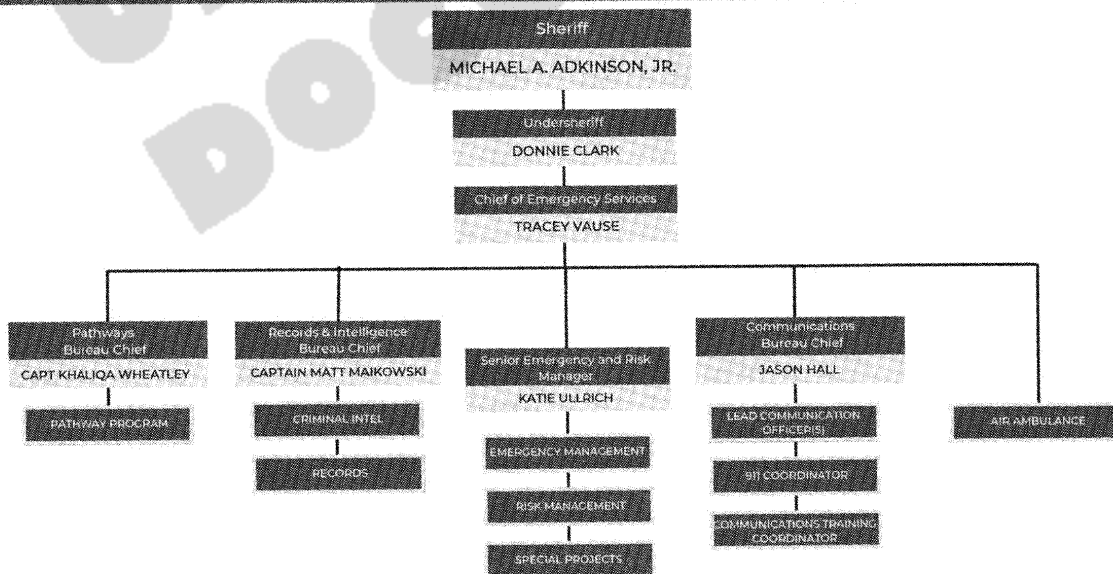

Emergency Services Division

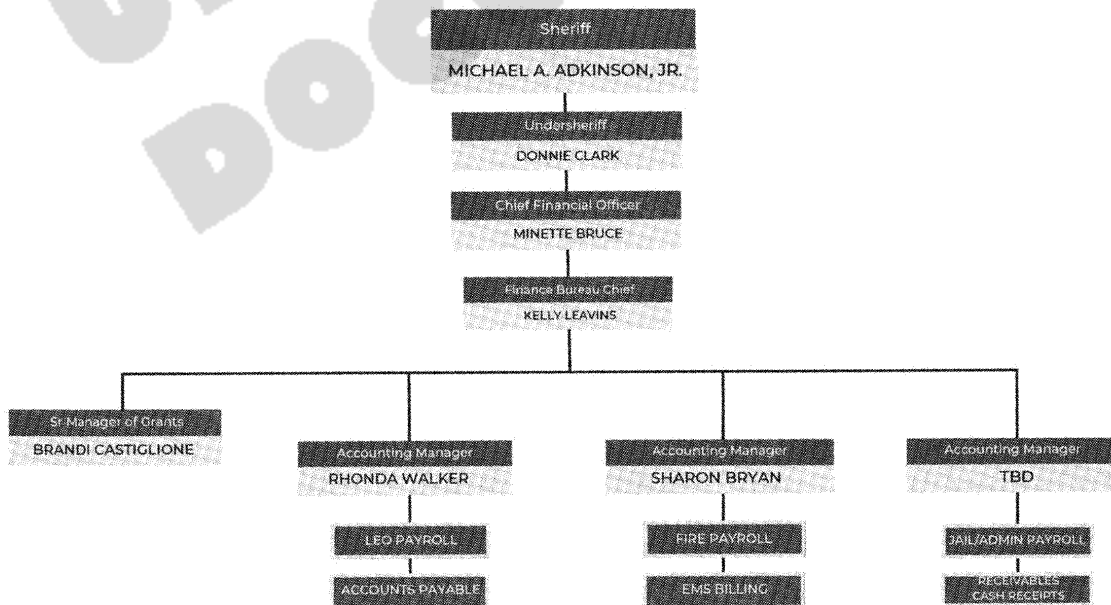
