COUNT 2: AND YOUR INFORMANT AFORESAID, PROSECUTING AS AFORESAID, ON HER OATH AFORESAID, FURTHER INFORMATION MAKES THAT **JOSEPH JAMES TURNER, between October 10, 2023 and January 22, 2024**, at and in WALTON County, Florida, did unlawfully, willfully, knowingly and without authorization disrupt or deny or cause the denial of the ability to transmit data to or from an authorized user of a computer, computer system, computer network, **Walton County**, the property of **Walton County**, in violation of Sections 815.06(1)(a) and (2)(b), Florida Statutes. **(F3-L1)**
